Chief Larrabee states that we have 33 patrol men -12 of them are in training that is 1/3 they do not count against minimums - there are days when we do not back fill and it's just a matter of numbers in contract language – my concern is not so much this moment but May and June and I probably going to discuss with the Mayor first and then with the union about pushing some of the vacations 90 days out if it can be done it may help us in the short term for the fiscal year. Next fiscal year is the year I think with all the people coming out of the academy that you are not going to see overtime numbers like you have seen this year. We still have 4 opening in detective, 1 in lieutenant soon to be 2 opening, and 3 openings inside. My strategy is not to do those promotions until we get closer to the end of the fiscal year. The department has had 26 turn overs out of 53 people in the last 2 years. One lieutenant is retiring August 1 who has 25 years and another with 25 years in not retiring and we have one person with 20 years in and the rest are very young officers so that is a good thing knowing no anticipated retirements other than Noreen Clough states to Chief Larrabee you say the patrol men by January 1st will be a full staff and promotions will be made will you have to hire again? Chief Larrabee states yes we will have to back fill for the patrol men but in the form of the detectives we have 4 openings and only 2 people passed the test so we will have to think that through. The same pool will be available to take the test again it's a matter of if they pass it. More importantly the supervisory back filling the rest we will have to hire. Most midnight shifts we are running on one supervisor and that is not good. Richard DePalma asks Chief Larrabee if we have ever thought about contacting the state police when we are short to get more assistance. Chief Larrabee states that other towns police have been used for events when we have been short staffed but not state and not on an average call. Roll Call Vote – All in Favor – Motion Carries.
