Police Chief Brent Larrabee states the man power (handouts passed out) we are finally up to where we should be. We made promotions to Lieutenant and Sargent positions, that is where our primary focus is on O/T because we were short on the midnight and 4pm shift, those will fill in those holes. 3 people are still in the Academy, we did have 6 officers that were coming out of field training last month one did not, he is still in training because he is in Marine Reserves and he is catching up on time. Sick and vacation has been minimal because 50% of the Police Department has been turned over. We went from 53 officers to 26 new ones and now have a very young force as well as supervisors. A few of the highest salaries pay periods were because of the Fireworks, and the other is from the Fall Festival, and one from training. Our goal is to get under \$20,000 per pay period. We will still be \$100,000 short but we also have some unused salaries such as 2 Detective vacancies so we have about \$71,000 a piece in each of those salaries therefore we have \$140,000 in unused salaries. We hope to come in around \$700,000 in O.T which is way down then what we did last year. My goal for next year is to be around \$600,000 or less. There is no one currently out on Compensation as well as long term injury or sick. We have a young healthy group. We only had one opening and hired a lateral transfer last night so he does not have to attend the Academy for training. We are in pretty good shape. Again my goal is to cut down on the O/T.
