# East Haven Board of Finance Special Meeting Minutes August 18, 2021

# **MINUTES**

The East Haven Board of Finance held a Special Meeting on Wednesday August 18, 2021 at 7:00 P.M. at the Town of East Haven Senior Center and Social Services, 91 Taylor Avenue, East Haven, CT. 06512

#### 1. Roll Call

Rich DePalma, Noreen Clough, Beth Purcell, and Al Purzycki were present. Mayor Carfora, Rich Esposito and Ralph Vitale were absent. Jim Keeley, Finance Director was also present.

Vice Chairman Rich DePalma asked for a moment of silence in remembrance of previous Finance Director, Paul Rizza.

## 2. Read and Approve Minutes from Meeting held on July 21, 2021

Noreen Clough made a motion to approve meeting minutes held on July 21, 2021. Beth Purcell seconds, all in favor.

#### 3. Old Business

It was asked how the audit is coming along. Jim Keeley stated it is coming along. Nothing out of the ordinary and all is going as planned. Jim Keeley hopes to have the books closed by the end of this month and there will be a letter going out to department heads to get all the old stuff in. Rich DePalma asked if the BOE was on track, and Jim stated he did not know but his conversations with RJ Caponera leaves him to believe they are on track. We have 2 sources of money for that, one was a special fund from people who are buying bricks and donations and then there is a \$25,000.00 line item. As the money comes in we use whichever fund has availability. Neither fund has run dry so far. I don't know the exact dollar amount.

#### Dear Chairman Depalma:

Due to a conflicting calendar, I am unable to attend the finance meeting August 18, 2021 to answer any questions regarding transfers to cover year end expenses for the 2020-2021 fiscal year so I am submitting the following explanations to help answer any questions you may have. If these answers are not sufficient, I will gladly return at the next meeting for you to take action on these transfers. Two payroll accounts and one operating account sustained overages this year, explanations are as follows:

Water Authority: 01-334-0202 overage \$16,500.00, the normal operating budget for this line is \$500,000 which only covers infrastructure maintenance for the public fire protection water supply. Hydrants are often damaged as a result of accidents or mechanical failure. During storms, the department typically sees an uptick in damaged hydrants and this past year was no exception. Whenever possible we file insurance claims to recoup costs for the replacement of hydrants, these deposits typically go to the general fund unless the department is paid directly by an insurance company. If a vehicle does not have insurance, or the hydrant was damaged by a town department as was the case this year, we cannot be reimbursed. The following hydrants required repair or replacement this year causing an overage:

- 200 Main Street \$8725.41
- 35 High Steet \$7837.02 (reimbursed)
- 650 Coe Avenue \$9712.29

Regular Salary: 01-334-0110 overage \$44964.33 Overtime: 01-334-0190 overage \$90818.61, during fiscal year 2020-2021 the department saw an unprecedented number of retirements totaling 8, the impact of which was compounded by existing vacancies, many personnel had over 30 years or had just met the 25-year retirement which is the minimum age to qualify for lifetime medical benefits. Vacancies accounted for seven-hundred-sixty-two (762) vacant shifts over the fiscal year. One-hundred four (104) shifts were vacant due to on-the-job injuries. COVID-19 accounted for fifty-four (54) vacant shifts during the fiscal year. The combination of these vacancies, injuries and quarantines / exposures accounted for \$397,256.78 in payroll expenses most of which were covered by our regularly assigned accounts. Vacancies grew throughout the year, the balance of which requires a transfer within our own department accounts. Vacancies throughout the year occurred as follows; July 1-16 (1), July 17-August 8 (2), August

9-17 (3), August 18-Mid-September (1), September-mid October (2), Mid October-January (3), Early to mid-January (4), Late January (5), February (8), Mid-April (12), then went down to (8) late April.

Vacancies have been mitigated for the time being, six (6) recruits start the academy August 30, one lateral transfer started August 9. New hires will finish the academy in December. There are anticipated promotions and up to three (3) retirements in the fall and a current civil service list will yield replacements for the winter academy training class.

Retirements are now stabilized, there are only 4 members of the department that are eligible to retire. Newer employees will realize a savings for the department in salary and accrued time.

I hope this explanation articulates the overage in the designated accounts. If I can be of further assistance or if there are any additional questions, I would be happy to appear before next month's meeting to provide additional information.
