Al Purzycki made a motion to discuss and refer to the Town Council. Rich Esposito seconds. Discussion: Chief Marcarelli presented and stated he has an explanation of the overages. We had \$9,675. Covid replacement costs. We had \$132,785. in on-the-job injury replacement, \$72,000.00 in military leave replacement costs. Actual costs of each one of those was covid \$9,658., on the job injury \$122,772.00, military leave was \$57,911.00 for a total of \$190,341. We did have 3 employees that were in the fire academy and we paid them approximately \$17,760.00 each for the 15 weeks they were in training plus a replacement cost in the firehouse. We also had one paramedic who needed extensive paramedic remediation on overtime and replacement costs for that were almost \$31,000.00 for a grand total of \$489,165.45. That explains my shortage in my salary line. We had enough in my other lines to cover that except for what we are going to contingency for. The gasoline/diesel-a few budgets ago the Town Council cut the gasoline line by about \$25,000.00 and I spend about \$60,000.00 on fuel and I explained to them we would continue to fill the trucks up and that is why I am short. Rich stated he appreciated the trucks being filled up and understands the gas prices continue to rise. Rich also asked if the 3 employees that went to the academy if they are full time staff. Chief Marcarelli stated they are full time staff. Al asked what is happening next year and if we are ok on gasoline diesel or will it be an issue. Chief stated the gas line was increased slightly. Jim Keeley stated that for 23/24 the fuel line was increased by \$22,000.00 and water was increased. It is much closer than it was.
