The East Haven Recreation and Athletic Complex Commission held a regular meeting on Monday, July 14, 2008 at the Senior Center.

CALL TO ORDER: The meeting was called to order at 7:35 P.M.

MINUTES: Motion was made by Commissioner Fronte and seconded by Commissioner Kluth to amend the minutes of the June 9, 2008 meeting of the East Haven Recreation and Athletic Complex Commission as needed, and file as amended with the minutes of the July 14, 2008 meeting.

CORRESPONDENCE RECEIVED: A request was received by Sherman-Williams Paint to use Masotta Field for a softball game and grill on Friday, July 18, 2008 from 11:00 a.m. to 4:00 p.m.

Motion was made by Chairman Pacelli and seconded by Commissioner Fronte to approve the request by Sherman Williams Paint to use Masotta Field on July 18, 2008.

A letter was received requesting permission to use the Gazebo on the Town Green for a wedding ceremony.

Motion was made by Chairman Pacelli and seconded by Commissioner Kluth to approve the request from Michael Brown to use the Gazebo on the Town Green on Saturday, August 9, 2008 from 7:30 p.m.

until approximately 7:45 p.m. with the understanding that the ceremony would be completed by dusk, cleanup would be done by the requestor(s), and no liquor to be permitted.

Vote was unanimous – Motion carried.

A letter will be sent by the clerk notifying Mr. Brown that his request is approved.

CORRESPONDENCE SENT: Chairman Pacelli sent Lori Musco a letter thanking her for her years of service as Clerk for this Commission.

Motion made by Chairman Pacelli and seconded by Commissioner Fronte to approve Anne Marie McGuire to the position of Clerk, Recreation and Athletic Complex Commission.

Vote was unanimous – Motion Carried.

PUBLIC SESSION: Discussion by the commissioners of dog-walking ordinances. Chairman Pacelli will request a meeting with Chief Gallo to discuss ordinances requiring owners to clean up after their pets, especially on the town beach, parks and ball fields. Discussion on providing clean up bags, more signage, etc.

DIRECTOR'S REPORT: Nothing was presented.

OLD BUSINESS: No old business was discussed.

NEW BUSINESS: Chairman Pacelli and commissioners commented on how well both the beach and the ice rink look. The Firework celebration was a success.

Brief discussion on a problem with the Bluefish game, and camp participants not being allowed to bring drinks into the stadium. Chairman Pacelli will discuss further with Lou Pane.

There will be a Movie Night on July 19, 2008 at 8:00 on the Town Green.

Chairman Pacelli stated that he submitted a letter of disclosure to the Town Council since his band plays in the Summer Concert series.

Motion was made by Commissioner Fronte and seconded by Commissioner Kluth to adjourn the meeting.
