## Special Meeting Minutes

### July 16, 2009

The East Haven Town Council will held a Special Meeting Tuesday, July 16, 2009, at 7:00 p.m. at the East Haven Town Hall 250 Main Street, East Haven, CT

Ralph Mauro briefly explained that the agreement would allow for Bennett Road to be repaved at the expense of the Water Company since it was their fault it was ripped up. Mr. Mauro stated that it was more than enough, and that they may possibly have enough left over to do a side road that was not originally planned to do.
