SEALED BIDS may be submitted to the Office of the Director of Finance, at the East Haven Town Hall, lower level, **250 Main Street, East Haven, Connecticut 06512**, until **10:30 AM local time, on Tuesday, December 15th** at which time they will be publicly opened and read aloud.

BIDS **MUST** be submitted on Forms and in the manner specified. Specifications and forms on which Bid **MUST** be submitted may be obtained at the Office of the Finance Director, Town Hall Lower Level, 250 Main Street, East Haven, CT 06512 on **Thursday December 3, 2015**. All inquiries concerning Technical Specifications for this Bid should be directed to **Kevin White, P.E., Town Engineer at (203) 468-3250**. Insurance or other requirements for this Bid should be directed to **Mr. Paul S. Rizza, Director of Finance at (203) 468-3210**. One original and two copies of the bid, along with the Cash Bid Bond in the amount of \$500.00 and references are to be submitted.

The Director of Finance reserves the right to reject any and all **BIDS** or to waive defects in same if it be deemed in the best interest of the Town of East Haven to do so.

It is the sole responsibility of the Bidder to assure the Bid is received by the proper authority prior to the Bid Opening time. Bids received after this time will be considered informal and will be rejected. No Bidder may withdraw their proposal within thirty days (30) of the date of the Bid Opening.

Minority and Female owned concerns are invited to participate and will be afforded full opportunity to submit Bids and are encouraged to do so.

INSTRUCTIONS TO BIDDERS

Sealed Bids will be received at the Office of the Director of Finance, 250 Main Street until the time and date specified In the Notice to Bidders. Bids received later than the time specified will not be accepted. Amendments to or withdrawal of any section of the submitted Bid received later than the time & date set for the Bid opening will not be considered. Bid proposals must remain in effect for a minimum of 60 days unless otherwise noted elsewhere in the Bid specifications. One original and two copies of the bid and supporting documentation are to be submitted at along with the bid.

BID DOCUMENTS: are available by contacting the Finance Department at 203-468-3210.

BID BONDS: If applicable, shall be In the amount of \$500.00 made out in favor of the Town of East Haven and Issued by a Surety company acceptable to the Town of East Haven, and must accompany each Bid. A Certified check, Cashier's check, Treasurer's check, or money order in the same amount may be submitted in lieu of the Bid Bond. Bids submitted without Certified Check or Bid Bond will not be accepted, The Town of East Haven will not be held liable for the accrual of interest on any check held by the Town in conjunction with this Bid. **All checks or Bid Bonds will be refunded to the unsuccessful Bidders after award of the Bid.** The deposit check or Bid Bond of the successful Bidder will be held in escrow as a **PERFORMANCE BOND** until such time as the Town determines that the Bidder has or will meet their obligations as stated by the Bid. If the Bidder fails or refuses within a reasonable time after due notice that the Contract has been awarded to execute the same, the Bid Bond shall be retained by the Town as liquidated damages. The Town of East Haven shall not be held liable if the contracted work under the provisions of the Bid are for any reason deemed unnecessary after the award. Bid Bond will be returned at the successful completion of the contract.

REPLIES: whether Bid or no Bid, must have the Bid number clearly identified on the outside of the envelope. Bidders not marking the envelopes with the BID number and date/time of opening on the envelope will have no recourse against the Town of East Haven or its employees. Such Bidders run the risk of the Bid being opened prior to the scheduled Bid Opening time. Once opened such Bids are public record. Any alleged oral agreement made by a Bidder or Contractors with any agent or employee of the Town of East Haven will be disregarded.

FREIGHT: Prices quoted shall be net delivery F.O.B. East Haven, CT. All Bid prices must include prepaid delivery, assembly, and/or Installation (ready for operation and/or use) of all equipment and/or materials to the Individual locations(s) as designated by the Town Engineer. All Bid prices are to be submitted on the sheets provided for this Bid. Quantities and pricing are to be listed in accordance with these sheets.

QUESTIONS: Request for Interpretation of any portion of the Bid *may* be made by telephone to the Town Engineer at 203-468-3250. All replies will be given verbally and a copy of any such Inquiry and advice (If deemed vital to the Bid by the Town Engineer) will be made available to each prospective Bidder In the form of an addendum.

NON-COLLUSION STATEMENTS: In order for Bids to be considered, a non-collusive statement must be submitted with the Bid. A sample non-collusive Bid statement is attached. Bidders may elect to submit their own notarized non-collusion statement.

CONDITIONAL, QUALIFIED OR NON-RESPONSIVE BIDS PROPOSALS: All Bids/proposals shall be submitted in the form and manner as indicated by the Bid documents and Bid forms. Any proposal which is not submitted in the form and manner Indicated by the Bid documents or which contains information, statements, conditions, or qualifications which place conditions or qualifications on the proposal submittal for purposes of making an award, or which alter any proposal terms, conditions, specifications, or forms, which have not been previously approved by **written addendum** from the Town Engineer, or which does not meet legal requirements, shall be declared as a qualified, conditional, or non-responsive proposal and shall be rejected without further consideration. Any proposal response that does not fully respond to and comply with all detailed specifications or requests for information, including execution or proposal forms may be declared "non-responsive" and recommended for rejection. The Town of East Haven shall not be responsible for any errors or omissions by the Offeror.

TAXES: Omit all State and Federal taxes from the Bid. The Town of East Haven is exempt from the payment of taxes Imposed by Federal government and/or the State of Connecticut.

OWNERSHIP OF DOCUMENTS: All documents, including drawings, plans, specifications videotapes or other documents or maps prepared by a Contractors pursuant to any agreement arising from this Bid shall become the property of the Town of East Haven upon completion of the project or any termination of the project prior to the completion of the project.

LEGALITY: All Bid offers for commodities, work, materials, or equipment hereunder shall comply in every respect with the laws, specifications and requirements of the State of Connecticut and the Federal government. Contractors will comply with the provisions of the Connecticut Fair Employment Practices Law.

LANGUAGE DISPUTES: Any disputes over the interpretation and/or meaning of any individual terms, conditions, and/or language within this Request for Bid/Proposal document shall be resolved by and at the sole discretion of the Town Engineer in a manner that is in the best Interest of, and best advantage to the Town of East Haven, provided any such interpretation shall be reasonable. In the event that an individual term, condition, and/or language/wording is determined at any time, Including after award, by the Town Engineer to be "not applicable at all" to this Contract, then the term, condition. and or language/wording may be disregarded, even though an addendum is not issued. However, if the Town Engineer determines that the term, condition, and/or language/wording "is applicable in part", then the term, condition, and/or language/wording will apply to the degree applicable, even though an addendum is not issued.

RESPONSIBILITY: The Contractors shall save the Town of East Haven, its agents or employees, harmless *from* liability of any kind for all claims of labor payments and materials furnished for this work, and for use of any copyrighted or uncopyrighted composition, secret process patented or unpatented invention, article or application furnished or used in the performance of the Contract of which the Contractors is not the patentee, assignee or licensee. The successful Bidder agrees to indemnify and hold harmless the Town of East Haven, its agents and employees from any and all liability arising out of the successful Bidders' operations, functions and/or supplied items.

The successful Bidder, vendor, and/or Contractors must protect all property of the Town of East Haven (i.e. all floors, furniture, roads, grass, land. etc.) from Injury or other damage. Any damage so caused must be repaired by Contractors/vendor at his/her own expense. At the completion of work, the vendor and/or Contractors must remove from the premises all surplus materials and all debris created by same. The premises must be left in a broom-clean and finished condition acceptable to the owner or Its agents, Successful Bidder will furnish adequate protection from damage for all work and to repair damage of any kind, for which he or his workers are responsible, to the premises or equipment to his own work or to the work of other Contractors.

DEFAULT: It shall be understood that Bidder supplying equipment and/or supplies will be considered to be in default if/when they have not delivered the item(s) within the time constraints listed In this document or subsequent purchase orders and/or Contract. Bidders providing a service and/or construction will be considered to be In default if/when they have failed to meet the completion date set forth in this document or Its subsequent Contract and/or purchase orders and/or they have ceased work on the project for a period of fifteen (15) working days, cumulative or consecutive,

TRADE NAME REFERENCES: Any and all references to trade names, types, styles, model numbers, stock numbers or catalogs are Intended to be descriptive only and not restrictive (unless so noted). The intention is to indicate to Bidders the type and quality of the articles and or materials that will be satisfactory. When reviewing the information, it is the responsibility of the prospective Bidder to Inform the Town of East Haven of any discrepancy that is found (i.e. number listed does not fit Item description). Bids received on other makes or models with reference to other catalogs will be considered. The Bidder is to clearly state in his/her Bid exactly what he/she Intends to furnish and to furnish with his/her Bid a cut or illustration or other descriptive mailer that will clearly indicate and give specification as to the product he/she proposes to furnish. Where a Bid is offered on an item other than the trade standard used in the specification the item should be identified on

the Bid form by entering the MAKE, TRADE NAME AND MODEL NUMBER. Determination of equivalence shall be at the discretion of the Town Engineer, whose decision will be final and without appeal. It is understood that any substitute and/or alternate that might be offered are guaranteed by the Bidder to be of equal or better quality than is referenced in the Bid. The item(s) must be equivalent as to function, basic design, type and quality of material, method of construction and any required dimensions. It shall be further understood that during original as well as subsequent shipments spot checks will be performed to insure that the Items received are in fact the items offered in the Bid. When received, should items/materials prove to be different from what was Bid in any way, the Bidder agrees to the return of the items and agrees to supply correct Items (per Bid specifications) at the Bidders expense. In the event this return action is required, It Is understood the Bidder may be subject to removal from the Town's approved Bidder's list. Bidders are cautioned that surplus, seconds, factory rejects, floor samples, close-outs or distressed Items are not acceptable and shipments of substitutions, defective *or* shop-worn equipment will be returned for a full refund at the vendor's expense.

QUANTITY: The quantities *and/or* materials listed in the specifications/Bid sheets may be increased or decreased by the Town of East Haven or its designated representative based on actual need at the time the purchase orders are placed.

QUALITY: The Town of East Haven reserves the right to reject any proposal in whole or in part offering equipment and/or materials and/or services that in its or its agent's opinion does not meet the quality standards desired. Such decision by the Town Engineer is final and not subject to further recourse by the Bidder.

SAMPLES: forwarded by the Bidder will be returned to the Bidder at his request and expense. Requests for return of samples must be submitted in writing at the time the sample is given to the Town of East Haven or its representative. Samples not returned to the Bidder will be disposed of at the discretion of the Town of East Haven or its designated representative. Large pieces of equipment submitted for evaluation and inspection are to be picked up by the Bidder within 60 days of the Bid opening date. The Town of East Haven or its designated agent will dispose of items not picked up within 60 days.

AWARD: It is the Intent to award this Bid to several/multiple Bidders, if necessary.

In determining the lowest responsible Bidder(s), the Town reserves the right to consider, in addition to price, the compatibility, quality, cost of maintenance and availability of parts, experience and/or past performance of the Bidder, sufficiency of the financial resources of the Bidder as relates to the offerings as well as the ability of the Bidder to provide future maintenance and service required.

Depending on the storm size and/or duration, the number of trucks necessary to keep Town roads open may vary

Documents previously submitted to the Town of East Haven will not be considered as satisfying submission requirements for this Bid.

Each storm throughout the winter season will present multiple/changing conditions. The Town, at its sole discretion, shall call Individual Contractors, beginning with the lowest hourly rate, to fill plow routes as necessary. If the lowest bidder is not available, the second lowest bidder/hourly rate will be called, until all plow routes are filled. This sequence will continue down the list as necessary throughout the winter.

OPTION TO RENEW: This Contract may be extended for three (3) additional one (1) year periods, provided all terms and conditions remain In full force and effect except for the Contract period being extended. This option, if exercised, is to be executed in the form of a letter of agreement, to be issued no

later than 30 days prior to the expiration of the then current Contract period. This option to renew requires the mutual agreement of both parties. Refusal by either party to exercise this option to extend will cause this Contract to expire on the original or mutually agreed upon date. The total period of this Contract, Including all extensions as a result of exercising this option, will not exceed a maximum combined period of three (3) years.

INSURANCE:

Certificate of Insurance: All Insurers must have an AM Best rating of A-VII or better and admitted to do business in the State of Connecticut. All Insurance policies must include a Waiver of Subrogation whereby the insured waives its right to subrogate against the Town, its subsidiaries, employees, volunteers, directors and officers. Proof of proper Insurance coverage, Workers Compensation Insurance, Liability and Property damage, and Vehicle Insurance shall be filed with the Town **OF** East Haven Director of Finance within 10 days after the award or the Bid. The Certificate of Insurance must name the Town of East Haven, 250 Main Street, East Haven, CT 06810, its subsidiaries, employees, volunteers, directors & officers as the additional insured and filed with the Town Engineer prior to commencement of work. Renewal Certificates of Insurance must be mailed to the Town Engineer 30 days prior to the expiration of the required coverage.

Workman's Compensation Insurance: The Contractors shall take out and maintain during the life of the Contract adequate Workman's compensation Insurance for all the employees employed on said work. In case any class of employees or Subcontractors is engaged In hazardous work under the Contract at the site of the work is not protected under the Workman's Compensation statute, the Contractors shall provide Workman's Compensation Insurance for the protection of employees not otherwise protected.

Liability Insurance: The Contractors shall lake out and maintain for the life of the Contract, adequate public liability Insurance insuring against liability to persons not employed by him In an amount of no less than \$1,000,000.00 for injuries, wrongful death to any one person and subject to the limit for each person In an amount of not less than \$2,000,000.00 on account of one accident and property damage insurance in an amount of not less than \$1,000,000.00.

Vehicle Insurance: The Contractors shall take out and maintain for the life of the Contract, adequate automotive/truck or other vehicle insurance with minimum coverage of \$1,000,000.00 each for both liability and under insured and uninsured motorist as well as any other coverage required by the State of Connecticut or requested by an official of the Town of East Haven as relates to the Contract.

Additional Security: The Town of East Haven reserves the right to require successful Bidders to enter into and such security arrangements as are deemed necessary to protect the Town of East Haven, its property and goods.

PERMITS: The Successful Bidder agrees to obtain all work/building permits as might be required. The cost of obtaining such permits is the responsibility of the Bidder. The Town of East Haven reserves the right to waive local permit fees. In addition, it shall be understood that where property lines are to be considered. Bidders are to verify said lines and measurements with proper Town Officials prior to commencement of work. It is to be understood that any/all specifications and/or plans or drawings contained in or developed as a result of the Bid process are and shall be presented subject to the approval of the Town of East Haven planning, zoning and building officials and that awards made prior to said approval are subject to cancellation.

PREVAILING WAGE: When the State of Connecticut Prevailing Wage Rate Is applicable to the Bid, the successful Bidder must submit a Certified Payroll Record prior to any request and/or invoice for payment.

SAFETY:

Machine and/or Equipment Hazard Assessment and Safety Training; Upon delivery of machines and/or equipment, suppliers are required to provide to the end-user employees, at no additional charge, a training session, which will emphasize hazard awareness and assessment and the safe use of such machinery/equipment

Occupational Safety and Health Act of 1970: Seller shall warrant that the machinery, equipment or other materials covered hereby shall upon delivery to the Town of East Haven, be in compliance with the standards required by said Act and any updates as pertain to or reference said Act as well as the standards required by comparable State and local laws, if any, for such machinery, equipment or other materials in effect at the time of delivery.

Machines and/or Equipment Lockout/Tag out: In an effort to comply with OSHA's final rule on the control of hazardous energy sources, vendors must warrant that any and all machines and/or equipment as is covered under this Bid will be supplied and/or Installed equipped with 10c;kouVtag out devices as prescribed by OSHA.

Toxic Substance Control Act (PL94.469): Seller warrants that each and every chemical substance consulting or contained In the products sold or otherwise transferred to the Town of East Haven under this Bid and subsequent purchase orders is not on the list of prohibited chemical substances compiled and published by the Administrator of the Environmental Protection Agency pursuant 10 Act P194-469 and are otherwise in compliance with said Act.

Hazardous Materials: Any materials required by this Bid and subsequent purchase orders that are hazardous under federal, state, or local statute, ordinance, regulation, or agency order will be packaged, labeled, marked and shipped by the seller to comply with all federal, state and local regulations then In effect including but limited to the provisions of the Hazardous Materials Transportation Act and Regulations promulgated there under and will further comply with any special requirements and any policies and procedures of the Town of East Haven relating to the purchase of hazardous materials as might be noted on subsequent purchase orders or otherwise communicated to seller in writing.

Material Safety Data Sheets: Shall be provided by the Seller upon delivery to the Town of East Haven of any goods hailing constituents listed in the following references _ OSHA 1910, ACHIG Current Threshold Values, DOT HazMat Table 49, IARC Carcinogen List, National Toxicology Program Carcinogen List, and/or Radioactive Materials. These Material Safety Data Sheets must be consistent with and include Information required by the OSHA Hazard Communication Standard, published as 29 CFR 1910, 1200, as the same may be amended or supplemented from time to time.

SUBCONTRACTORS: The successful Bidder shall not employ any Sub-Contractors to fulfill any of the duties herein specified without express, prior written approve of the Town of East Haven or its designated agent.

EEO: The Successful Bidder shall provide any/all additionally required, affirmative action statements, fair employment plans and non-discrimination programs and statement as might be required by the Town of East Haven. In connection with the execution of this Bid, subsequent purchase orders and/or Contracts, the seller shall not discriminate against any employee or applicant for employment because of age, race, religion, color, sex or national origin. Bidders must comply with all rules & regulations of the Department of Labor with regard to Equal Employment Opportunities as pertains to municipalities.

TERMINATION OF CONTRACT: Any Contract entered into by the Town and the successful Bidder shall provide that the Town may terminate the Contract upon thirty (30) days' notice to the Bidder.

The Town of East Haven reserves the right to award the Contract to the lowest responsible Bidder, or reject any or all Bids, or any portion thereof, to waive technicalities, and to award the Bid and for Contracts to one or more Bidders submitting essentially identical proposals and, that in the Town's Judgment, will best serve the Public Interest.

The terms and conditions of these "Instructions to Bidders" are made a part of this Bid.

Special Conditions - Town of East Haven Bid # 15-11

1. Contractors shall provide trucks and operators for the entire winter season (Dec. 22, 2015 through April 30, 2016), as required during storms, and shall be assigned a definite route for plowing and sanding. This is a necessary Public Service; therefore a penalty shall be assessed against any Contractor for delays in reporting, after the one (1) hour time, up to the maximum number of hours such service requires during any storm which the delay occurs. The penalty shall be \$175.00 per truck per hour commencing two (2) hours after each truck was called, up to the maximum time the vehicle(s) would have been needed.
2. The vehicles of successful Bidders shall be inspected at and by the East Haven Public Service Dept. at 461 North High St., East Haven, CT., before any snow-plowing is done. Discrepancies shall be corrected before any plowing is authorized. Failure to correct discrepancies shall result in default on the part of the Contractor and cause for dismissal. The Town of East Haven shall have the right, but not the obligation, to select the next qualified bidder and assess the defaulting Contractor for any additional costs incurred.
3. Contractor shall pay for the repairs, fuel, insurance and taxes. In times of emergencies, the contractor, under extreme conditions, May purchase fuel from the East Haven Public Services Department for a cost of \$3.50 per gallon. This cost shall be deducted from the bill owed for work performed. The Town of East Haven will supply sand and salt at all times. These conditions are not to be expected in an average storm
4. Contractors must assign same driver every time there called out, except in the event of illness. Contractor shall have relief drivers available in the event of prolonged storm events. Contractor shall provide the town the name of the primary in relief drivers in the Connecticut Driver's License Numbers (CDL where applicable.)
5. All work performed by contractor shall be reviewed by East Haven Public Service Department. Unsatisfactory performance, as determined by Charlie Coyle, the E. Haven Hwy. Foreman, who is the authorized representative of the town, may be grounds for termination of any contract resulting from the specifications. Such authorized representative decision shall be final and the contractor shall be paid for actual work done to the time of dismissal, less any additional costs incurred by the town for correcting deficiencies.
6. Proof shall be provided to the Highway Foreman, Charlie Coyle, that each driver is part of the DOT – approved drug and alcohol testing program. Failure to do so shall be grounds for not accepting any such driver and cancellation of the contract.
7. Truck shall have a metal body of contractor's, type, preferably single-axle; minimum, gross weight of 28,000 pounds; under frame hoist and mold board; 11 ft. preferred and minimum of 10 ft., complete with snow plow, optional bid: truck with sander installed. Contractor trucks must be equipped with auxiliary lights, chains, if needed, snow tires with excellent tread, adjustable plow lights, flashing light, and a cellular phone, fully charged and continuously activated. Such cell phone numbers will be made known to the East Haven Public Service Department "snow" dispatcher immediately upon reporting for work.
- 7A. As a second bid Item, the Town will accept bids for medium sized trucks. Truck shall have a metal body of contractor's, type, preferably single-axle; minimum, gross weight of 19,000 pounds; under frame hoist and mold board; 9 ft., complete with snow plow, optional bid: truck with sander installed. Contractor trucks must be equipped with auxiliary lights, chains, if needed, snow tires with excellent tread, adjustable plow lights, flashing light, and a cellular phone, fully charged and continuously activated. Such cell phone numbers will be made known to the East Haven Public Service Department "snow" dispatcher immediately upon reporting for work.

8. A minimum of four (4) hours' time shall be guaranteed for each truck operator called out and actually reporting.
9. Contractor shall keep their trucks in operable condition during the term of this contract to the response to request for service can be rapid. It is expected that the contractor shall be able to begin plowing within two (2) hours of receipt of request for services. Operable condition shall be that as approved by the Public Service Department after inspection (see #2).
10. Anytime a vehicle is not operable after it starts work, the contractor shall not be compensated by the Town if the cause for the inoperability is breakdown of Contractor's equipment. Payment will not be made for timeout for meals or sleep.
11. The contractor's operator shall, for safety purposes, take a "meal break" approximately every six (6) hours of work and such break shall be scheduled by the Town's authorized representative.
12. Time to change the snowplow blades, which will be furnished by the public works department and installed with the help of the contractor's personnel, shall be included in calculating the number of hours on the job.
13. Front springs of truck shall be sufficiently strong to carry the additional weight of hoist snowplow. Rear tires shall have clearance to allow installation of single or dual chains. Each contractor's truck shall be equipped with an airlift, hydraulic, for snowplow operations and adequate defrosting devices.
14. All vehicles proposed for use must be registered in the State of Connecticut.
15. Contractors and drivers shall at all times, observe and comply with all local, state and federal, (including OSHA) laws, ordinances and regulations when providing the services. Contractor shall indemnify and hold harmless the town, and all of its officers, agents and servants against any claim or liability arising from or based on violation of any such law, ordinance or regulation, whether by themselves or their employees.
16. It is understood by each successful bidder in the performance of its obligation to provide snowplowing services that he/she is acting as an independent contractor and not as an agent or employee of the town of East Haven. The bidder acknowledges it is an equal opportunity employer and will comply with all the laws and regulations relating to employment.
