Item #11A

- Chairman Ken Mckay says the Council members all received documents from Councilman Joseph Santino showing illegal signs being hung on businesses throughout the Town. Some of them block views for example on Hemingway and Dodge Ave.
- Councilman Joseph Santino says he went all over Town after getting some
 complaints and it is getting worse instead of better. The flag signs they use are
 totally illegal, we don't allow them and they are all over. The signs are hazardous;
 they blow into the road like the one on Coe and Silver Sands where the car had to
 swerve around it. It is getting out of hand and we need to get back in control over
 this, it looks trashy.
- Councilman Big Steve Tracey asks if this is for the ones on fences or the buildings, because they are allowed to put them on buildings, correct?
- Councilman Joseph Santino says he is talking about both, they are allowed to put signs on the building but to an extent because there is an ordinance for it.
- Sal Brancati-Director of Administration & Management says if you measure the fascia of your building you are allowed 10% of the square footage of the front of your building that faces the street to put signs.
- Councilwoman Judy Esposito asks about the a-frame signs.
- Councilman Joseph Santino says those are completely illegal according to the
 ordinance. He mentions Oceanport, which has a sign on the fence that is about 6ft
 x 7ft and also one across the front of the building which were put up by liquor
 distributors.
- Councilman Nicholas Palladino says he did speak with the zoning officer about other problems and in a round about way he told him that he is only one person and has one part time staff member. Maybe the part time person should be made

full time because there are enough building and zoning problems going on and they don't want their town to start looking like Fairhaven. Maybe they need to think about adding that in the budget or put another part timer so someone can be out looking and seeing what is going on.

- Councilman Joseph Santino says he isn't looking to fine anyone it can be as simple as walking in and showing them what the rules are and telling them that the signs have to come down or they will be fined. They can show them the violation and give them x amount of days to take them down. They can even put it in the mail to them showing them the violation and telling them it has to be corrected in x amount of days.
- Councilwoman Judy Sittnck says she thinks it should be done in writing.
- · Mr. Brancati says they have on numerous occasions sent letters out to people telling them that they are in violation of the sign ordinance. For example Soundauto put signs up on the building, giving them the benefit of the doubt because it is circular they used the diameter of the building as the fascia and they promised the signs would be taken down but it has been a month so now the fines will begin.
- Councilman Joseph Santino says they just put new signs up that are illegal.
- Councilman Big Steve Tracey asks about the large flag signs that are up, those are illegal everywhere?
- Councilman Joseph Santino says yes.
- Chairman Ken Mckay says yes because they can come down and hurt someone or cause problems. He asks Attorney Zullo his recommendation on this.
- Attorney Zullo says the Council doesn't have jurisdiction over this but they can send a letter to the ZEO saying the Council is looking
-at what appears to be violations of the Town's sign ordinance and the Council would appreciate them being looked into because they are becoming an eye sore. He says he can write the letter or the letter can come from the Council clerk.

Councilman Joseph Santino makes a motion to instruct the clerk to send a letter to the zoning enforcement officer requesting that he look into the alleged violations in light of the Council's discussion tonight.

Councilman Nicholas Palladino seconds the motion.

Roll call vote: all in favor-none oppose-none abstain. Motion carries.
