Council comment:

Re: Bond Rating Upgrade

Dear Chairman Parlato and Honorable Town Council Members:

As many of you may have read in today's edition of the New Haven Register, Standard and Poor's, one of the world's leading credit rating agencies, recently awarded the Town of East Haven an historic two-tier upgrade in its bond rating from "A-" to "A+." This upgrade marks the second credit rating upgrade for our Team and for the Town of East Haven since 2014, when Standard and Poor's raised the Town's rating from "BBB+" to "A-." As S&P noted, the upgrade reflects management's follow-through in balancing our budgets, keeping taxes stable, restoring our rainy day fund, and paying down our long-term debt by \$25.5 million dollars (or 47%) in just five years.

While this office, in conjunction with our Finance Director, has taken the lead in charting a careful fiscal course for our community these past five years, the Legislative Town Council has also played an integral role in the Town's financial recovery. With bipartisan support each budget season, your Council has adopted the vast majority of our recommendations, even when those decisions were not easy. As a team, we've worked hand-in-hand to engineer a remarkable financial recovery for our community while still maintaining an exceptional level of services for our residents.

Although there is cause to celebrate this exciting financial news, I must also caution your Council that our efforts to restore the rainy day fund have only brought it up to the "5% minimum" level recommended by S&P. While our improved bond rating certainly means we will obtain more favorable rates when we elect to borrow money, we must still be cautious about limiting our borrowing and keeping spending under control in order to preserve and continue to improve our credit rating.

Although significant work still remains, I would like to thank this Council for its support of this administration's fiscal policies and for your bipartisan efforts each budget season. I am confident that with sustained teamwork in future budget cycles, we will continue to prosper for years to come.
