Looking at the surrounding Towns, we look pretty good; we are maintaining our mill rate, adding to our fund balance, are not cutting any services and are adding to the reserve in case anything comes up, they are prepared for it.
- Councilman Parente also wants to thank Paul Rizza for his assistance going through this budget on a daily basis. As the Chairman said if you look within 5 miles of our Town, the Town of West Haven is on the brink of bankruptcy, North Haven has a 5 mill increase. We are in phenomenal shape considering the economics in the State of Connecticut. He hopes they don't get a letter from Hartford saying this budget would have to be reopened. He thinks this is a phenomenal budget; there were a lot of increase in a lot of line items, everyone here contributed to the budget. He doesn't think anyone went along party lines he thinks they made cuts where they needed to, they made cuts that have been on their minds for a couple of years and brought forward some opinions and made some resolutions in that respect.

An Ordinance adopting the Town and Board of Education Budgets and fixing the tax rate in mills for the 2016-2017 fiscal year of the Town of East Haven.

WHEREAS, in accordance with the provisions of the General Statutes of the State of Connecticut and the Town Charter of the Town of East Haven, this Council is empowered to adopt a budget and set the tax rate in mills, 31.55 for the 2016-2017 fiscal year;
