Applicant and Property Owner: William and Carol Traester: Property Affected: 176 Beach Avenue; Map 020, Block 0107, Lot, 004; Zone R3, Application for construction to add a two story addition to rear of the property (north side) with a tower on the top of addition.

Variance: <u>Section 25, Schedule B, Line 9</u> reduction of side yard setbacks where 20 ft is required to a setback of 3 ft on the west side of the property and 3 ft on the east side of the property

Section 25.4.3 Additional Setbacks to allow an increase in height to 31 ½ feet for copula where 30 is required, 1 ½ feet increase

William Traester addressed the Board. He was seeking a variance to add a two story addition to rear of the property (north side) with a tower on the top of addition and the aforementioned amended variances. Hardship: Lot is too narrow to comply with zoning regulations. The height of addition with cupola would be 31 ½ feet.
