The East Haven Board of Finance will held a Regular Meeting on Wednesday February 21, 2018 at 7:00 P.M. in the Mario Giaimo, Joseph Vitale Meeting Room on the lower level of East Haven Town Hall, 250 Main Street, East Haven, CT 06512

Vice Chairman, Richard DePalma calls to order the meeting at 7 p.m.

1. Roll Call

The vehicles are custom fit for the Police Department with equipment but the Mayor's car is not equipped with anything but a low frequency radio. Noreen asks what and are we getting anything from the state for money. Paul Rizza stated that they have not finalized anything as of yet. Beth Purcell states that for the sub-committee meeting she will not be able to volunteer for these meetings this year as she is very busy at work. Paul Rizza asked if Beth could send a template to him of the minutes.
