BOARD OF EDUCATION

ACCOUNT CLERK I, GRADE LEVEL 10

The exam is complete. 4 candidates from the prior list were offered the opportunity to retest or keep their old score and transfer it to this list because the prior list has not expired yet. They all chose to have their scores carried over to this list. 26 new candidates applied for a total of 30 applicants. 4 candidates did not have enough experience to take the test, 3 failed, 5 did not show for the exam and 14 passed. The list has a total of 18 Candidates (14 from this test plus 4 carried over from prior exam).
