Six officers signed up to take the exam. They are currently preparing for the exam which is scheduled for February 13, 2014.

**NEW BUSINESS**  
**POLICE DEPARTMENT**  
**POLICE OFFICER C-NEW RECRUITS**

The Police Chief submitted a letter requesting the removal of one candidate from the Eligibility List for Police Officer C. They also requested a Certified List to fill 4 positions.

A MOTION was made by Mr. Carocci to remove Melvin Lopez from the Eligibility List for Police Officer C.

**INDEX CLERK**

The employee in this position has retired and a union member has bid on it as a lateral transfer. Due to the hiring freeze imposed by the Mayor there will be no movement at this time.

**NEW BUSINESS**  
**2014/2015 BUDGET**

The Chief Examiner has submitted the budget for the next fiscal year to the Board of Finance. There have been no changes to this year's budget. The Board of Finance Budget Workshop has not been scheduled; she will notify the Commission members when a date has been set.

A MOTION was made by Mr. Carocci to add the item of "Testing-Police Officer C" to the Agenda.

The Board of Police Commissioners has requested a new test be administered for the position of Police Officer C. The list will expire in June and there are less than 10 names left on the list. The Commission discussed the cost of administering this exam and if there was enough money left in its budget to cover the cost. The Chief Examiner stated she was working on a proposed request to the Board of Finance based on the cost of test rental and foreign language testing which make up the majority of the expense. Ms. Asid stated she felt the first step should be to secure funding from the Board of Finance before any other decisions are made.

A MOTION was made by Ms. Asid to request funding from the Board of Finance for the Police Officer C Exam.
