READING AND APPROVAL OF MINUTES

A MOTION was made by Mr. Stacey to accept the minutes of the September 10, 2012 Regular Meeting as submitted.

OLD BUSINESS

POLICE DEPARTMENT

POLICE OFFICER C-NEW RECRUITS

The Police Commission has hired 3 new recruits and 1 P.O.S.T. Certified Officer.

A MOTION was made by Ms. Abbott to certify the employment of Ryan Gorman, Michael Jobes, Franshesca Ojeda Crespo, and Milton DeJesus effective October 1, 2012 and to send them the standard probationary letter.

Mr. Stacey seconded.

DETECTIVE EXAMINATION

The exam is finished with three candidates completing the process.

A MOTION was made by Ms. Abbott to establish the Eligibility List to be valid for a period of two years and to certify the top 3 available names in ranked order to fill one position.

SERGEANT AND LIEUTENANT EXAMS

The weight assigned to each part of the test was discussed. Ms. Abbott was not comfortable making any changes at this time. Mr. Stacey said he supported the change in weighting of the portions of the exam but would respect Ms. Abbott's opinion regarding this. He stated it could always be revisited in the future. The new job descriptions were discussed but some information has been left out. The Chief Examiner will check on this with the Chief and the matter will be addressed next meeting.

A MOTION was made by Mr. Stacey to begin the testing process for the positions of Sergeant and Lieutenant with a written component worth 2/3^{rds} and an oral component worth 1/3rd with a pass point of 60 for both parts of examinations to be valid for a period of 2 years.

NEW BUSINESS

YOUTH DETECTIVE EXAM

The Board of Police Commissioners has requested an exam for Youth Detective. This will need to be conducted after the Sergeant and Lieutenant Exam.

A MOTION was made by Mr. Stacey to begin the testing process for the position of Youth Detective with a written component worth $2/3^{\text{rds}}$ and an oral component worth $1/3^{\text{rd}}$ with a pass point of 60 for both parts of examinations to be valid for a period of 2 years to be posted after the completion of the Sergeants and Lieutenant Exams.

PUBLIC WORKS

TREE TRIMMER

The position has been posted for a lateral transfer and no one bid on it. Frank Gentileco requested the commission begin the process to fill the position.

A MOTION was made by Ms. Abbott to begin the testing process for the position of Tree Trimmer with a written exam worth 100 % of the final score and a pass point of 60 to be valid for a period of 2 years.

BOARD OF EDUCATION

TEMPORARY EMPLOYEES
