There will need to be a new test given, Chief has been in contact with the Civil Service office to get this on their agenda.

Comm. Nastri questioned about the candidates still on the list. Chief explained that most have already gotten jobs since the last test, and a few may no longer be interested. Chief also explained that most of the other Departments are having the same issue.

Comm. Nastri also questioned if individuals have to be Paramedics would sending them to school help solve this problem. Chief answered sending the individual to school is not cost effective, paying salary while at class, paying overtime to cover shift, just not a good idea to hire non-paramedic.

Comm. Depalma questioned about Firefighters retiring, is it still going to be a problem to have EMT's ride the trucks in the future?

Chief mentioned that EMT's now ride the trucks as well.

Chairman Leonardi questioned if the Lateral move from other departments is still effective. Can we advertise this again.

Chief answered that this is an ongoing region wide impact that the need of Paramedics is great.

Comm. Nastri stated we may need to look into the option of hiring and look into sending individual to Paramedic School and list it in budget.
