3. Delivery time may affect award of bid.
4. Available manufacturer's service/operating literature and warranties to be provided for each and every component of this unit at time of delivery.
5. The Town of East Haven will not be obligated to add the additional options to the base bid price when ordering.
6. The Town of East Haven will hold the successful bid prices firm for a period not to exceed one (1) year from the date of award.
7. This bid may be extended two (2) times. Each time for a period of one (1) year provided that both parties agree.
8. Envelope(s) must be plainly marked BID, with the purpose and time of opening.
9. Bids must be submitted on the bid sheet.
10. Vehicles are to be completed within ten (10) business days from the time they are received on location.
11. Proof of insurance to cover transportation, indoor storage, and product liability must be provided with The Town of East Haven as additional insured.
12. Bidders shall not use vehicles for commercial advertisement, i.e., print, social media, etc., without permission from the Town of East Haven.
