

Notice of Testing

The Civil Service Commission announces an open-competitive examination for the position of Firefighter D/Paramedic in the East Haven Fire Department

SALARY:	\$56,074.98 per year, 42 hours per week, rotating shifts

Duties: See attached job description.

Qualifications: Candidates must possess/adhere to the following list of qualifications:

- A valid Driver's License from the State of Connecticut
- A High School Diploma or GED
- Must be 18 years of age
- Current licensure as a Paramedic or be currently enrolled in a Paramedic Program capable of completing the program within 2 years,
- **Valid CPAT Card**-Candidates become eligible for employment once they submit a valid CPAT Card.
 - Candidates who submit a CPAT Card *before* July 9, 2018 will be eligible for employment for the first round of hiring.
 - Candidates who submit a CPAT Card *after* July 9, 2018 will be eligible for employment in a subsequent round of hiring.
- Pass a physical examination, drug screening and background check in addition to Civil Service Testing.
- Must not use tobacco products.

Application Fee: There is a \$50.00(\$20.00 FirefighterApp.com; \$30.00 Town) fee payable Online to FirefighterApp.com.

Examination: The examination will consist of a written exam with a pass point of 70 which is worth 2/3rd of the final grade; an oral exam with a pass point of 70 which is worth 1/3rd of the final grade and the Candidates Physical Ability Test (CPAT) administered by the Connecticut Fire Academy which will be a pass/fail grade and accepted anytime during the life of the list.

Additional credit may be awarded after successful completion of all phases of the exam:

- Candidates who believe they are eligible for Veteran Credit must attach copy of DD214.
- Candidates with college credits may be eligible for the Education Credit and must request an Official Transcript from their college or university be sent to The Civil Service Office, 250 Main Street, East Haven CT 06512 and be received by 7/9/18 to receive credit.
- Candidates may be eligible for Foreign Language Proficiency Credit by attaining a rating of “Intermediate-High” on a Foreign Language Competency Exam. Candidates who believe they are fluent in a foreign language must submit the “Foreign Language Proficiency Examination Credit Request” form available with the application to The Civil Service Office, 250 Main Street, East Haven CT and complete the test by July 1, 2018.
- Candidates who possess Firefighter I Certification in the State of Connecticut must submit proof to The Civil Service Office, 250 Main Street, East Haven CT 06512 and be received by 7/1/18 to receive credit.
- Candidates who possess EMT Certification in the State of Connecticut must submit proof to The Civil Service Office, 250 Main Street, East Haven CT 06512 and be received by 7/1/18 to receive credit.
- Candidates who possess Paramedic with Medical Control Certification from New Haven Sponsor Hospital must submit proof to The Civil Service Office, 250 Main Street, East Haven CT 06512 and be received by 7/1/18 to receive credit.
- Candidates who have successfully completed the Connecticut Fire Academy Recruit Training Program within the last 5 years must submit proof to The Civil Service Office, 250 Main Street, East Haven CT 06512 and be received by 7/1/18 to receive credit.
