The YAMAHA personal watercraft offers the most stable vessel for the mission of the officers and has proven to be the most reliable when it comes to operations in adverse weather, lower maintenance cost and overall durability.

There is a hole in the hull of the vessel that is currently plugged that was intended to draft water from for firefighting purposes.
