6. New Business –

#18-03 Shore Line Trolley Museum: Placement of trolley car in the 50' setback.

Wayne Sanford from the Shoreline Trolley Museum was in attendance. The Trolley Museum is requesting to move the trolley that currently sits at the hotel on Frontage Rd. The Museum has always maintained ownership of the Trolley and it was most recently used as a visitor's center. The Hotel is undergoing renovations and the placement of the trolley is not conducive to the new plans. The Museum would like to utilize it for display and meetings as it is air conditioned and heated. They are proposing ballasts, ties and rails approximately 10-15 feet from the top of the bank. The car would be moveable in the event of an emergency but not connected to the main rail line. Mr. White requested sedimentation and erosion controls be put in place and maintained during the work. It should take approximately 2 weeks to complete the work. A motion was called for by the Chairman, was made by Mr. Cubellotti and seconded by Ms. Nastri.
