1. Call to Order

Chairman Jerry Jaffe called the meeting to order at 7:00 PM

6. New Business – Recommend/select a volunteer to serve as a Wetlands Associate

Mr. Jaffe had some thoughts on a volunteer position that would serve as a Wetland Associate/Liaison. This person would serve on a renewable basis. They would provide services such as record retrieval on an item by item basis. They would have input regarding agenda items but no voting privileges. They would be required to maintain confidentiality. The commission members in attendance thought it was a great idea, but might be hard to fill since the commission is still not full. There will be additional thought and work put into this in order to further define the position. Mr. Jaffe had also done some research into the meeting status of 12 surrounding shoreline towns. He looked at 3 years of minutes and found the average IWWC meets 11 times

per year. The most meetings per year were 18 and East Haven 'was dead last' just holding 3 meetings per year. It was again noted that the Commission has vacancies that have not been filled in quite some time. The Town Attorney has told Mr. Jaffe that these vacancies are a priority.
