Discussion of Public Act No. 21-1 AN ACT CONCERNING RESPONSIBLE AND EQUITABLE REGULATION OF ADULT-USE CANNABIS; Public Act No. 22-103 AN ACT CONCERNING CANNABIS; and Public Act No. 22-104 AN ACT CONCERNING CANNABIS ADVERTISING AND THE DEPARTMENT OF CONSUMER PROTECTION'S RECOMMENDATIONS REGARDING VARIOUS REVISIONS TO THE CONSUMER PROTECTION STATUTES. A presentation will be given by counsel and the Council and Commission will be receiving information regarding cannabis establishment uses. Public comment will be permitted, and East Haven residents and property owners and other interested persons may attend and offer their comments.
