Minutes of Special Meeting Held Monday, December 19, 2022 Via Zoom Videoconference and Conference Call

I. Roll Call and Pledge of Allegiance

Members in attendance: Marlene Asid, Vice-Chair; Robert Cubellotti; and Allen Shaul. John Tarducci and Louis Fusco were excused.

Also in attendance: Sotonye Otunba-Payne, Clerk/Court Reporter; Joseph Budrow, Planning and Zoning Administrator/ZEO; and Jennifer Coppola, Assistant Town Attorney.

Ms. Asid called the meeting to order at 7:08 PM. The Pledge of Allegiance was recited.

II. Public Hearing

1. <u>Application No. 22-19</u> – East Haven Planning and Zoning Commission. A Petition for a Text Amendment to the East Haven Zoning Regulations to extend an existing Moratorium that prohibits the issuance of any zoning permits that would permit the use of a Cannabis Establishment in any zoning district in the Town of East Haven for a for an additional period of three (3) months to March 31, 2023.
