The East Haven Planning and Zoning Commission held its Regular meeting on Wednesday, June 5, 2019 at 7:00 PM at the East Haven Community Center, 91 Taylor Avenue in order to transact the following:

Chairman DeMayo called the meeting to order at 7:03 p.m.

Roll call- 3 present (DeMayo, Lang, and DiMartino) 2 absent-(Marrotti and Asid)

Staff Present: Christopher Soto, Zoning Official, Alfred Zullo, Assistant Town Attorney, and Salvatore Brancati, Director of Administration and Management.

1a) Accept/Approval of Minutes from the May 1, 2019 meeting.

Commissioner Lang moved to approve the minutes.

Chairman DeMayo recognized the applicant who explained that this is not a change of use but he needs the approval of this commission to get his license. He typically repairs his company's tractor trailers.

Commissioner DiMartino asked if it is all facets of truck repair.

The applicant indicated mostly for their own trucks but do other work too.  
Commissioner Lang asked how they deal with hazardous waste.  
The applicant stated that the state contract for waste oil is part of the license.
