8- 24 Referral – To consider and act upon a favorable 8-24 report and approval of a resolution designating the Town of East Haven as a rehabilitation area and establishing criteria for the eligibility of real property for assessment increase deferrals.

Attorney Zullo explained that under the Luzzi administration the commission approved this type of assessment criteria as an opportunity to bring new business to town. It is a huge help to attract new business. The 10 years is the most lucrative of deferral assessments and the town has all to gain and nothing to lose.

Chairman Ruocco asked if the utilities are still underground and if there are the same physical features with lights and sidewalks. "This meets with my approval."

Zoning Official Biancur indicated that the Mayor wants sidewalks on both sides of the street. Commissioner Giamattei moved for re-approval with the conditions of the engineer.
