Vice-Chair Adamczyk seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

With regard to the CT Chiefs Football team, Commissioner Porto made a **MOTION** to allow the team to use the Town fields for nothing. There was no second. **MOTION DENIED**

Commissioner Anastasio made a **MOTION** that Commissioner Porto contact Mr. Mancinelli from the CT Chiefs and inform him that he has one week to send a check in to the Recreation Department for the amount previously approved and send in the Proof of Insurance or the contract is terminated for use of the fields for 2 hours on Saturdays and in the future. Commissioner Morganti seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

**New Business**

Because of the resignation of Chairman Santomassimo the commission must reorganize. Commissioner Anastasio made a **MOTION** to nominate Joan Adamczyk for Chairperson. Commissioner Porto seconded. It was asked three times if there were any other nominations. There were none. **MOTION CARRIED**

Commissioner Morganti made a **MOTION** to nominate Lou Anastasio as Vice-Chair. Commissioner Porto seconded. It was asked three times if there were any other nominations. There were none. **MOTION CARRIED**

Chairwoman Adamczyk made a **MOTION** to formally change the time of the meetings to 7:00 p.m. Commissioner Morganti seconded. All were in favor, none were opposed and none abstained. **MOTION CARRIED**

There being no other business to come before the commission, a **MOTION** to adjourn the meeting at 7:43 was made by Commissioner Morganti and seconded by Commissioner Porto. All were in favor, none were opposed and none abstained. **MOTION CARRIED**
