#### 2021 Schedule of Meetings:

Chairman Raffone asked the Members of the School Building Committee to review the 2021 Schedule of Meetings that was sent to them. The Members reviewed it and accepted the schedule. ### **Report on Football Field:**

Eric Roise, Architect, reports the contractor is currently working and never stopped working on this project. The Track surface is in and the track has been striped and covered in plastic. The weather has been setting the project back because the adhesive swells in the rain. Once everything is completed, the field will be tested. Eric Roise replied the vendor was paid \$500,000.00 to date and everything is on schedule and the progress payment will be coming tomorrow. The percentage billed is 75% because it includes track work.
