The East Haven Board of Finance held a Special Meeting on Tuesday, June 23, 2020, at 7:00 P.M. via ZOOM, in order to transact the following:

I. Roll Call

Mayor Joseph Carfora, Richard DePalma, Noreen Clough, Beth Purcell, Ralph Vitalie, Rich Esposito and Al Purzycki were present. Jim Keeley, Finance Director and Attorney Michael Luzzi were also present.

Noreen Clough made a motion to move X to the front and make it 1a. Beth Purcell seconds. All in favor. Motion carried.

Noreen Clough Made a motion to refer to the Town Council and to discuss. Beth Purcell seconds.

Discussion: Attorney Michael Luzzi stated this is a transfer to payback legal fees from primarily Lynch, Traub, Keefe and Errante. It is addressing a fee that occurred about 70-80% prior to November 1, 2019. This will be the money to put some of those back fees behind us. Attorney Luzzi referenced our (BOF) February meeting which he addressed the need to probably come back for some contingency money to address those back legal fees. This amount should be enough to address all the back fees, most of which are Lynch, Traub, Keefe and Errante and a couple of other labor related fees that were occurred prior to November 1, 2019.

Al Purzycki asked if these were the last of the surprise bills that we will see. Attorney Luzzi stated he believes so. Lynch, Traub, Keefe and Errante were asked a few months ago to outline what was past due. There was a delay because of Covid 19. Attorney Luzzi stated we are continuing to litigate some matters that predated us so there will be costs associated with that.

The \$25,000.00 that is on the Agenda we already acted on (item VIII) per Attorney Luzzi.

Noreen made a motion to discuss and refer to the Town Council, Beth Purcell seconds. Discussion: Jim Keeley stated the police department is looking at leasing police vehicles. Jim stated the Chief presented two numbers from a municipal leasing credit corporation one for a 3-year lease for \$138,000.00 per year, one at 4-year lease at a \$105,00.00 per year. Jim Keeley stated they did not put police vehicles in the regular budget this year. Jim further stated that they are trying to avoid putting it in the capital improvement budget, so this would allow us to start the leasing program going forward. There is more to be done as far as getting all the costs, but we need the transfer to start the process or else we must put getting new cars for this year onto this year's capital improvements. This is using old authorized money to start the leasing process and this money should cover us for the first 2 years of leasing. Beth Purcell asked how many vehicles we are talking about and is this coming out of the operational budget or their bonding. Jim stated that once we start the lease program we would like to get out of their regular budget. Jim stated the funds we just asked for 20/21 does not include police vehicles in their regular budget because we didn't want to put an extra burden on the tax payers because we went up on the mill rate. The money has already been authorized and the thinking is re-classified and put a down payment on lease program so this year would not be in the capital improvement program. Rich DePalma asked Jim Keeley if these were all previously pre-approved bonding. Jim stated this bonding goes back to 2013. Beth Purcell asked how many vehicles and Jim said the quote he has is 6 to 8 police vehicles. So far it is just one quote and the whole 344k is not for that one lease it is to basically start the program up and keep it going; it stays in the general operating budget. Rich DePalma asked if this is over a several year period. Jim will confirm with police chief. Jim's understanding is that they were going to try to get 6 or 8 new ones and some of the

older vehicles we have are still serviceable and keep them as backups. Al Purzycki asked if the moneys we are taking from are moneys we don't need. Jim stated that when they originally went through the DOJ investigation, they wanted to be certain to have more than enough funds. You don't know until you go through the process. Al asked if we are going to have a problem with recertification of police officers more frequently in the future. Rich DePalma answered and stated that what we went through with the DOJ puts us ahead of many departments in this state so the training that our officers received through the DOJ training is a step above many towns. Noreen backed that up stating she believes they did put some of that in the budget for certification and knows when we bonded this money for the DOJ we bonded more than we thought we might need because we were not sure how we would come out of it. Al sees change and wants to be sure we are going to be covered with the changes that have occurred in the last month or so. Rich DePalma stated that if the Governor institutes change above and beyond what we budgeted for that is something we will have to address in the future. Rich DePalma asked Jim Keeley if a car is totaled or damaged is this something we must pay up front. Jim stated we are self-insured so regardless of whether we own the vehicles or lease the vehicles we are in the same boat for property damage. This is in the preliminary stage and there would be buyouts at the end of the lease for a \$1.00 for a capital lease. The thought is trying to trade them in and put toward the next lease. Ralph Vitale stated a capital lease is basically your buying the car because it has a bargain purchase so instead of financing it the lease is a finance payment so at the end of the lease you give the dollar and it is your car.
