of aggrievement. After hearing, the town council may affirm, modify or rescind such order. (Ord. of 9-15-72, § 3)

# Sec. 11-29. Marking of zones; costs to be borne by owner.

Upon establishment of a fire zone, the police department shall cause to be erected or installed, adequate signs, markings and other devices to delineate said fire zone. Signs, markings, and other devices erected or installed on privately owned premises, shall be at the cost of the owner, and may be billed for, and collected in the same manner as municipal taxes, provided the police department causes a notice of lien to be filed on the land records within sixty (60) days after such erection or installation. (Ord. of 9-15-72, § 4)

### Sec. 11-30. Parking prohibited; exception.

No person shall park, or permit to stand, a motor vehicle in a fire zone which has been established in accordance with this division, except when actually picking up or discharging passengers. Any person violating this section shall be subject to punishment as provided in section 1-11 of this Code. The registered owner of a motor vehicle shall be presumed to be the operator of such vehicle. (Ord. of 9-15-72, § 5)

### Sec. 11-31. Removal of illegally parked vehicles.

Any motor vehicle found standing in a fire zone which has been established in accordance with this division may be towed, upon the direction of a police officer, to any public or private parking facility, and all expense of such towing, and any subsequent storage, shall be borne by the registered owner of such vehicle. (Ord. of 9-15-72, § 6)

## **DIVISION 3. WINTER LIMITED PARKING**

# Sec. 11-46. Parking in off-street facilities required when available.

From November fifteenth of each year until April fifteenth of the following year, all vehicles shall be parked on off-street facilities where such off-street facilities are available. (Ord. No. 156, § 2, 11-8-78)

### Sec. 11-47. Restrictions where off-street facilities are unavailable.

If off-street facilities are not available, vehicles shall be permitted to park only on the even numbered sides of streets within the town during the period from November fifteenth to April fifteenth; provided, however, that on such streets where posted parking regulations either presently or in the future limit the parking to the odd-numbered side only, vehicles shall continue to be parked on the odd-numbered side only, subject to the removal of such vehicles for snow cleaning purposes, as provided in this division. (Ord. No. 156, § 3, 11-8-78)

## Sec. 11-48. Moving of vehicles during snow alerts, etc.

During snow alerts or snow storms or such other times as the mayor may deem appropriate, the owners of vehicles shall be required to remove their vehicles from the even-numbered sides of the street to the odd-numbered sides of such street or such other plowed area as may be available in such a manner as to not block or impede traffic on the travelled portion of such street within six (6) hours after the odd-numbered sides of such streets have been plowed and cleared to allow the even-numbered side of the street to be similarly plowed and cleared. Such owners of vehicles shall be required to remove their vehicles from the odd-numbered sides of the street within six (6) hours after the even side of the street has been cleared and plowed. Notwithstanding the above, the mayor or the chief of police, if they deem it necessary, shall be empowered to order the removal of all vehicles from any or all streets within the town to permit efficient and effective snow removal. (Ord. No. 156, § 4, 11-8-78)

### Sec. 11-49. Enforcement.

The police department of the town shall have full powers to enforce the provisions of this division and shall be empowered to "tag" vehicles providing for fines or penalties not to exceed twenty-five dollars (\$25.00) for each violation. In addition thereto, the police department shall be empowered to order the towing of vehicles which the department deems necessary and the owner of such towed vehicle shall be required to pay such towing cost in addition to any other fines or penalties. The police department shall have all other rights and powers as provided by law. (Ord. No. 156, § 5, 11-8-78)

# Sec. 11-50. Towing charges.

All garages and other companies which tow or otherwise remove motor vehicles under the provisions of this division shall assess rates and charges which do not exceed the rates approved by the motor vehicle department of the state. (Ord. No. 156, § 6, 11-8-78)
