### Special Meeting of the Town Council Minutes

The East Haven Town Council held a Special Meeting, Monday, May 3, 2021 at 7:00 p.m., in order to transact the following Via Zoom.

Chairman Deko called the meeting to order at 7:09 p.m. Pledge of Allegiance Roll Call-13 Present 1 Absent (Ruggiero) Staff Present: Town Attorney Michael Luzzi, Stacy Gravino Town Clerk, James Keeley Finance Director, and Bruce George Library Director.

Chairman Deko read the executive order into the record and thanked the council members and department heads for all their hard work and their bipartisan efforts.

#### Item #1

Vice Chairman Pacelli moved to consider and act upon the enactment of an ordinance adopting the Town and Board of Education portion of the budget and fix the tax rate in mills for 2021-2022 fiscal year for the Town of East Haven.

Vice Chairman Pacelli read the ordinance in its entirety as follows:

# ORDINANCE ADOPTING THE TOWN AND BOARD OF EDUCATION BUDGET AND FIXING THE TAX RATE IN MILLS FOR THE 2021 - 2022 FISCAL YEAR OF THE TOWN OF EAST HAVEN

#### BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF EAST HAVEN:

WHEREAS, in accordance with the provisions of the general statutes of the state of Connecticut and the town Charter of the town of East Haven, this council is empowered to adopt a budget and set the tax rate in Mills for the **2021-2022** fiscal year; and

WHEREAS, the Council has reviewed the budget submitted by the Mayor and has held public hearings thereon; now, therefore, be it ordained:

Section 1. Anticipated revenues for the 2021 - 2022 fiscal year are as follows:

Section 5. The tax rate in Mills to be levied on the taxable property in the Town of East Haven is hereby fixed at a rate of <u>34.25</u> Mills.

Section 6. All bills for Real Estate, personal property and motor vehicle taxes for the fiscal year which total \$200 or less shall be due and payable in full on July 1st 2021. Bills for such taxes which total more than \$200 shall be due and payable in two installments, one-half (1/2) on July 1, 2021, and one-half (1/2) on January 1, 2022.

Section 7. This ordinance shall be effective in accordance with the provisions of the Town Charter of the Town of East Haven.

Vice Chairman Pacelli moved to approve as presented. Councilwoman Glassman second the motion. Councilwoman Glassman comments were specifically for the Board of Education; she feels very comfortable for a number of reasons the substantial funding for Covid Relief and the Essar Funding as well therefore, she feels very comfortable with what is before her at this time. It's a good and fair budget.

Jim Keeley, Finance Director stated the bottom line did not change from last year's budget.

Chairman Deko made mention, that in an effort to hold the bottom line the mayor's staff did not get any raises to help hold the mill rate at the same and we would like to extend our appreciation.

Councilman Santino thanked everyone for a great job and that they were able to give funds to all the civic groups in town.

Councilman Balter thanked everyone for their commitment in coming together and to give back in many ways; we have shown great fiscal responsibility.

Councilwoman Cesare stated that she agrees and it is the first time that all civic groups have received funds.

Councilman Pacelli thanked the taxpayers for allowing him to serve and thank you to his fellow council.

Councilwoman Hennessey stated that she is on the same page and a lot of people should be happy we came together for the tax payers and town services.

Councilwoman Parlato echoed the same sentiments we all appreciate being heard.

## Roll Call Vote-12 In favor. 1 Opposed Councilman Maltese who stated that he strongly believes in education and the council should have approved the funds they requested. No Abstentions. Motion Carried.
