## East Haven Town Council

### Minutes

The East Haven Town Council held its Regularly Scheduled Meeting Tuesday, October 4, 2022, at 7:30 p.m. or immediately following certain public hearings at the East Haven Community Center, 91 Taylor Avenue, East Haven, CT in order to transact the following:

Vice Chairman Pacelli called the meeting to order at 7:29 p.m.

Roll call-8 Present 6 Absent (Parlato, Stacey, Santino, Martin, Deko, and Glassman)

Vice Chairman Pacelli asked for a moment of silence for all those devastated by the hurricane in Florida.

**PUBLIC COMMENTS**

Cindy Sparago, 42 Caroline Road spoke in opposition about short term rentals.

Town Attorney, Michael Luzzi indicated that the town is actively working on an ordinance with substance and will have a presentation in that regard.

Lorena Venegas, 73 George Street spoke in opposition to several issues; the skate park, D.C. Moore, and the expansion of the airport.

Jean Chieppo, 173 Henry Street spoke in opposition to the airport expansion.

Anthony Campizano, 48 Hughes Street spoke in opposition to the airport expansion.

Georgia Lieber, 18 Hampton Road spoke in opposition to the airport and has serious concerns with regard to public health and ecology. Also, asked if there is an environmental impact study.

Town Attorney, Michael Luzzi agreed with some of her comments and assured the public that the town has hired special counsel to deal with the expansion and we represent the town who is our client, so there is an attorney-client privilege in place. There will eventually be an update.

Salvatore Ferraro, 57 Waldo Street spoke in opposition to the airport expansion.

Mario Piscitelli, 48 Waldo Street spoke in opposition to the airport expansion.

Clement DeLucia, 18 Bretton Street spoke in opposition to the airport expansion.
