# EAST HAVEN TOWN COUNCIL REGULAR MEETING MINUTES TUESDAY, FEBRUARY 5, 2013

The East Haven Town Council held a regular meeting Tuesday, February 5, 2013, at 7:00PM at the East Haven Senior Center, 91 Taylor Avenue, East Haven, CT 06512.

Chairman Richard Anania asks all to stand for the pledge of allegiance.

Chairman Anania asks all to remain standing to say a prayer for Democratic Registrar of Voters Joe Buonome who is ill.

#### Item #1

Roll Call- 10 present- 5 absent (Esposito, Richardson, Badamo, Riolino and Carbo)

#### Item #2

Approval of minutes from January 16, 2013 Special Meeting-

Councilman Joseph Santino makes a motion.

Councilwoman Beverly Gravino seconds the motion.

Roll call- all in favor- none oppose- none abstain. Motion carries.

## Item #3

No Correspondence.

#### Item #4

Subcommittee Reports-

- Public Safety- nothing to report
- Board of Education- nothing to report
- Parks/Recreation- nothing to report
- Finance- nothing to report.

Attorney Joseph Zullo asks the Council to make a motion allowing him to discuss a few items with them that are not on the agenda. They are not things that need to be voted on, just things he would like to ask the Council.

Councilman Santino makes a motion.

Councilman Robert Cubellotti seconds the motion.

Roll call- all in favor- none oppose- none abstain. Motion carries.

## Attorney Zullo address the Council-

- Attorney Zullo asks the Council's opinion on changing the Town Ordinance for public meeting times. Right now it is a Town Ordinance that requires all boards and commissions of the Town to meet after 7:00. He states that it was enacted in 1987 and there were only very minor changes in 1992 and 2001. The ordinance reads that no board meeting shall commence earlier than 7:00 and no meeting of a subcommittee before 5:00. He asks if the Council would be interested in changing it from 7:00 to 6:00 which he feels may be a benefit especially during budget season; normal meetings could still be conducted at 7:00 or 7:30.
  - Councilman Robert Parente and Councilman Santino state that they have no problem with that.
  - Councilman Fred Parlato states that he feels the whole purpose of the designated time is to get as much public input as they can. If it is moved from 7:00 to 6:00, for those who do not work in East Haven by the time they get home from work, take care of their families and get to the meeting, it puts a handicap on it. He adds that he hasn't heard complaints about it being too late even during late budget meetings, but in order to have disclosure he sees no reason to change it.
  - Vice Chairman Robert Sand agrees with Councilman Parlato in that the
     7:00 was designated for that reason, to give people time to get there.
  - Councilman Parlato adds that they do not get as much public input as they should, changing it may lead to not having anyone in the audience.
  - o Councilwoman Gravino asks if 6:30 would be a compromise.
  - Chairman Anania asks if it can just be changed when they are doing the budget.
  - Attorney Zullo explains that the Council can do whatever they want, it can be changed just for budget and regular meetings can stay the same. He states that he will talk to other boards as well since it could also affect them. He concludes that he will draft something and bring it back to the Council to see if they like it or not.
- Attorney Zullo states that the second thing is an email he received from Ed Lennon regarding the DOJ Compliance Agreement training that is part of the agreement. They will be holding a training session for the Board of Police Commissioners on February 19<sup>th</sup>, 2013 at 7:00 PM at the East Have Police Department. He explains that members of the Board of Finance expressed an interest in it and they wanted to extend the invitation to the Town Council as well if any of them wanted to receive the same training.

- Councilman Parente asks what the capacity is to which Councilman Gary Depalma states they could fit about 45 people at the PD.
- Chairman Anania asks what kind of training it is.
- Attorney Zullo explains that it is the 2-4 hour mandated training required in the agreement. It is a training session on the agreement itself.
- Attorney Zullo presents the last thing to the Council which is in regards to the standing rules of the Town Council which control how the Council functions. He states that the last time they were changed was in 1992. Some of it is outdated, some of it is not. He states there are minor tweaks he would like to make but he wanted to ask the Council first before he drafted something. He asks if the Council would be open to possible modifications, since it determines how the board runs he would draft something, get copies out and then it can be discussed.
  - There was no opposition- Attorney Zullo states that he will draft something up and present it to the Council within the next couple of months.

Attorney Zullo explains that the reason for this change is that he spoke with Attorney Sgrignari who stated there is an immediate need for these funds to be made available, they are moving forward quickly and trying to meet the deadlines of the compliance agreement. In order to do so they need to have the money in place in order to not violate the charter.

Councilman Santino asks if they will be going to the Council explaining what the money is being used for. Attorney Zullo states presumably they will be telling them what it is being used for, and that night these things can be discussed.

Roll call - all in favor- none oppose- none abstain. Motion carries.

**BE IT RESOLVED**, that Joseph Maturo, Jr., be, and hereby is, authorized to sign the agreement entitled "Second Supplemental Agreement between the State of Connecticut and the Town of East Haven for the Construction, Inspection and Maintenance required in conjunction with the Replacement of the Maple Street Bridge (Bridge No. 04881) over the Farm River utilizing Federal Funds from the Highway Bridge Program."

Councilman Santino makes a motion Councilwoman Gravino seconds the motion.

- Arthur DeSorbo- Director of Administration & Management- States that he will let the Town Attorney discuss this, but explains that he went over this with the Town engineer who signed off on the supplemental agreement.
- Attorney Zullo explains that in 2010 the Town executed a supplemental agreement, this will be the second supplemental agreement the Town has executed. The primary driving reason for this is that it has taken extra time to finish. The goal is for everything to be done by May 31<sup>st</sup>, he explains he has worked very hard with the other attorney to solve any existing problems when they took over in November of 2011, they made payments to the contractor and then some time did get away from them. He states that the supplemental agreement does six things that he will explain.
  - The primary thing is that if we spent more than is allowed under the contract, it requires us to go execute a new contract and if there is federal funding available, we have to obtain state approval and then we are entitled to reimbursement. Essentially, it says it wants them to stay within the contract which to date he can say we are doing pretty well with.
  - 2. It corrects a grammar and reference change in article 33; it is just a reference change.
  - It rephrases a monthly reporting responsibility that we have when a
    contractor is preforming active construction; we have to report monthly on
    finances and statuses of construction. We had this responsibility already,
    the phrasing of the paragraph has changed but it is still the same
    responsibility.
  - 4. Refers to total project cost which is a bit lower than the previous supplemental agreement, it reflects a lowering of costs for certain physical goods. As the prices of sand, fill, etc. rise and fall, and new agreements are executed, those numbers change slightly.
  - 5. A grammatical update and an update of all state executive orders that we have to be in compliance with which is in almost every State and Federal agreement, for example the Civil Rights Act.
  - 6. Asks us to be in compliance with certain administrative and statutory requirements, they are the same responsibilities just reinstated. The biggest requirement is that we submit federal auditing; we do one of those every year.

#### Council comment:

- Vice Chairman Sand asks about page 2, he was looking for what the final expense is.
- Attorney Zullo states that we are still waiting for the return of state funding; we
  pay the contractors and wait for the state to reimburse us. We are waiting for
  \$100,000 in reimbursement and we have roughly the same amount in upcoming
  expenses, between \$60,000 and \$100,000 to finish out the project.

- Vice Chairman Sand states that on page 2 item 4 states that the estimated cost is \$3,105,635 and the maximum reimbursement is \$2,359,368 leaving a difference of \$746,267, is that still accurate.
- Attorney Zullo states that we are only entitled to 80% reimbursement and the
  Town Council went out years ago and bonded for that difference so that money is
  sitting in the account. He states that he presumes that Town figured out the
  amount of reimbursement and bonded for the difference and put that bond in the
  account. He adds that number does reflect an increase in the cost, including the
  costs for the engineering firm that had to go back and do a redesign.
- Councilman Santino and Sand express a concern for change orders.
- Attorney Zullo states that we are still in negotiations for some of the change orders but the goal is to have the whole project completed by May 31<sup>st</sup>.
- Councilman Parlato asks if the Town has an recourse going back to whoever
  designed this or the State because they had to approve the design and it seems
  many things in the design were overlooked such as manholes and different
  things which added to the cost and held the job up. He expresses concern that
  the Town should not have to pay any more than originally agreed upon.
- Attorney Zullo states that so far we are working within the framework of the total bonded money and the total that we came up with in the beginning. He adds that the idea of litigation has come up a number of times, and it would be complex litigation and he is looking to avoid litigation at all costs because he feels the Town would end up paying more money in legal fees than it will ever recoup, which is not in the best interest of the Town. Attorney Zullo states he has done everything he can to keep this matter from ending up in the courts and he will keep trying to do that because he feels they will spend so much more in legal fees and it is not worth it to the taxpayers.

#### Public comment:

- Donna Richo- 67 Charnes Drive, East Haven- Ms. Richo asks if the addendum to the contact is relieving the State from paying the 80% and passing it on to Federal.
- Attorney Zullo states that it is his understanding that it was always Federal
  obligation, these were Federal funds. He adds that it may block down from
  Federal and then move down to the State and come to Municipalities through the
  State so there is a perception that it is State money, but to his knowledge it all
  originated federally.
- Ms. Richo adds that her concern is whether we give up anything in doing this addendum which says "if" federal funds are available.
- Attorney Zullo expresses states that he doesn't believe any of this ever originated with the State, it can be just semantics because to his knowledge it was always Federal. If we did go over, we would have to talk to congress.
- Ms. Richo asks if we are in compliance with all executive orders.
- Attorney Zullo states presumably we are at all times; we do our best to stay
  abreast with all of them. We keep a book of them and there is municipal
  education and training on this and a resolution is passed yearly to state we are in
  compliance.

- Ms. Richo asks if the addendum requires any additional reporting.
- Attorney Zullo states that the only additional reporting he saw was the active construction which all they essentially did was change the name of the form, it didn't change the frequency of reporting at all.
