## Council comment:

 Councilman Anthony Mansi seeks clarification in that there are several Boards/Commissions that members of the Council sit in on and report back to the Council about, so who reports back to the Council for these other boards.

- Councilman Mansi makes reference to the last Council meeting which involved the Tweed New Haven Airport Authority, there are members on that committee and the Council knows nothing about what they are doing.
- Attorney Zullo states that as the Town's Legislative body, the Council is always
  welcome to invite a board or commission chairman or representative to come
  speak to them regarding an issue that will be on the agenda.
- Councilwoman Gravino says don't they keep minutes for the boards/commissions. Attorney Zullo says yes they do and those minutes are posted online.
- Councilman Richardson states that some boards are Mayor appointed, and asks
  if these Council appointments only. Chairman Anania says yes, these are the
  boards/commissions that the Town Council appoints.
