The required certified receipts were submitted. Hardship: Homeowner has nowhere to live and house is uninhabitable. Donald Thomas questioned how long the mobile home would be needed, Mr. Delafield responded six to nine months. After a brief discussion by the Board they agreed to impose a condition on this variance. See voting. Sal Cascagno 196 Foxon Blvd, and Ronald Paolillo 198 Foxon Blvd were in favor of this application. No further comments were made.
